

WHAT EXACTLY IS AN ENDOWMENT?

An endowment fund is a long-term investment where none of the contributions are spent, but a portion of earnings is released as an annual grant for specific purposes defined by the individuals or agencies that sign a written agreement.

Endowment grants - now and in future generations - provide supplementary income to the parish budget.

As Christian Stewards, we recognize that all good gifts come from God and we are called to share them with love and charity. Besides returning a portion of our financial blessings to God through the parish offertory, we also have an opportunity to remember the parish with a gift in a last will or estate plan. Such a legacy gift to a parish endowment can be considered the ultimate act of financial stewardship.

Charitable gifts in any amount may also be made to an endowment in honor or memory of a loved one, or in lieu of flowers at the time of a funeral.
